Wisconsin

Overview The Kenosha County Bike Trail runs for nearly 8 miles in two sections separated by couple miles with the city of Kenosha.



Wisconsin–Illinois state line at Russell Road. Tract housing and open space make up the adjacent surroundings for this portion of the trail, but trees enveloping the corridor provide shade and a sense of seclusion.

Connections

At the state line, a bridge over Russell Road offers connection to Illinois' [Robert McClory Bike Path](#).

At the northern county line, the trail seamlessly morphs into the [North Shore Trail](#), which extends farther northward into the City of Racine.

The northern portion of the Kenosha County Bike Trail connects to the [Kenosha Pike Bike Trail](#).

The Kenosha County Bike Trail is part of the Route of the Badger, a developing trail network in Greater Milwaukee, Wisconsin.

Overview

The Kenosha County Bike Trail runs for nearly 8 miles in two sections separated by couple miles with the city of Kenosha.

About the Route

The northern segment runs between 1st St. (Kenosha-Racine County Line) and 35th St. The surroundings become increasingly rural as the trail heads north, and trees along the corridor provide welcome shade in the summer months. Near the private Kenosha Country Club, the trail passes close to the Pike River.

The southern segment travels between 89th Street to the

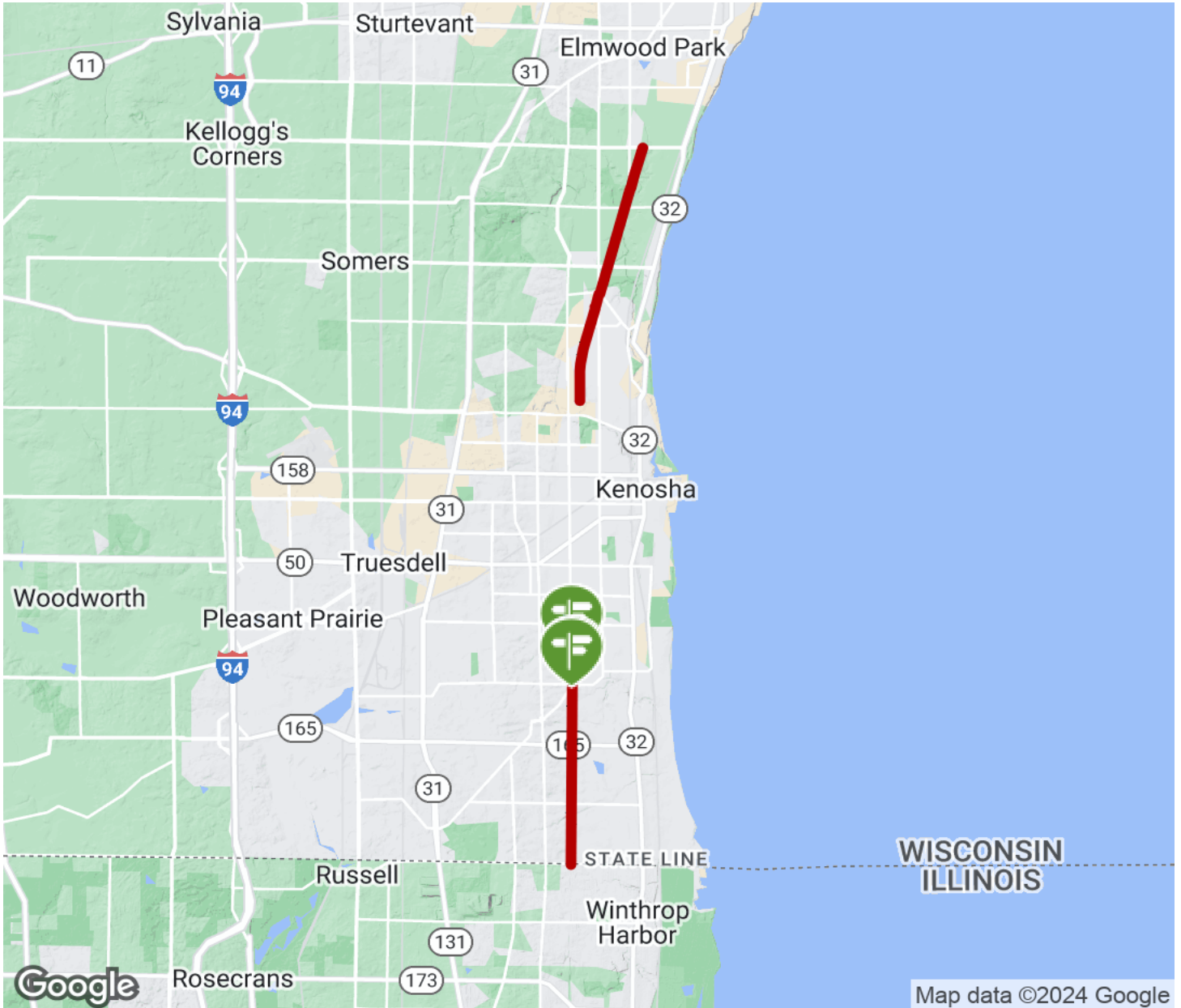
