At just over 20 miles, the North County Trailway is the longest of four rail trails created from the former New York Central



At just over 20 miles, the North County Trailway is the longest of four rail trails created from the former New York Central Railroad's Putnam Division line. The trail travels through communities in West Chester, just north of New York City, and provides a respite in nature from the urban sprawl surrounding the city.

The trail trends somewhat downhill as it heads south toward the connecting South County Trailway. Vegetation protects sections that pass through residential and commercial areas or run next to roads. Two short sections (one spanning 0.5 mile and the other 0.8 mile) use the shoulder of Saw Mill River Road.

About the Route

The northern end of the North County Trailway is located in the West Chester community of Baldwin Place. From here, the trail heads south and passes the 1830's Amawalk Friends Meeting House on Quaker Church Rd. Along this section of the trail (near where it crosses Granite Springs Road), there are a number of pick-your-own apple orchards.

As the trail crosses through the business district of Yorktown Heights, which sports a number of Revolutionary War landmarks, trail users may also be able to spot an old Putnam Division railroad depot. Three miles south of here, the trail passes through the Kitchawan Preserve and crosses the New Croton Reservoir on a rail trestle bridge.

South of Millwood, there are two short sections of on-road trail, one of which takes trail users by Echo Lake State Park. This section of trail also passes the a short spur trail, that trail users may take to the Briarcliff Manor Library, which was originally one of the 23 railroad depots that served commuters in Westchester County. This section of the pathway follows alongside the Potantico River and Saw Mill River Rd.

As the trail continues south, it skirts Pocantico Hills and the Rockefeller State Park Preserve as it curves toward its southern endpoint, which continues directly along the South County Trailway.

The North County Trailway runs along the New York Central Railroad's Putnam Line, "Old Put" railroad. Several mid-19th-

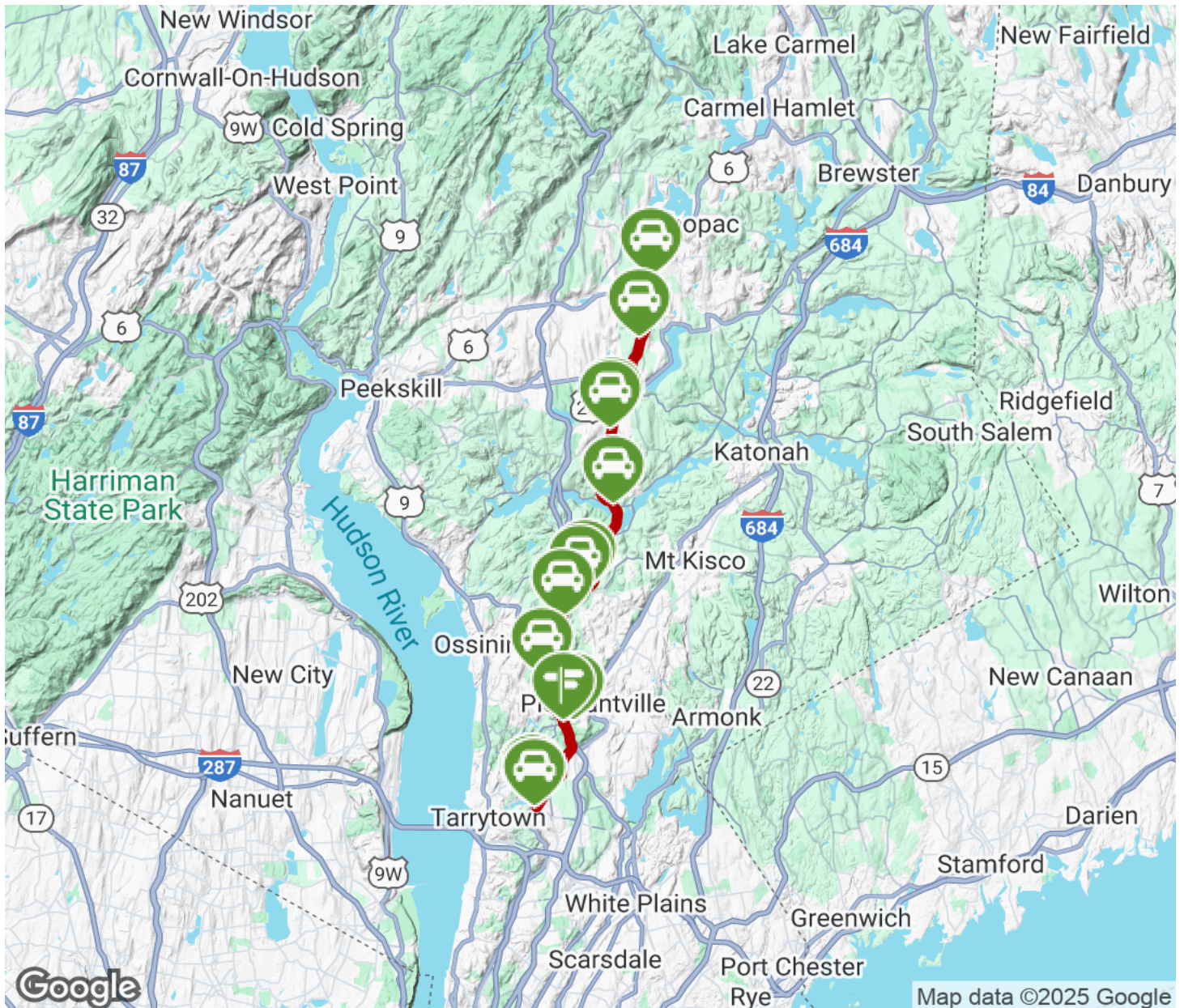
